Proposal #1—Add a new subsection under the Duties of Secretary/Treasurer.

New Article—2.4.10-Shall be paid an honorarium sum of \$200.00 annually at the end of the month of September. Sheri Mize accepted. Lori Rojas seconded. Amended as effective immediately. Sheri Mize proposed to tend it next year. HOLD

# Proposal #2—Add a new section:

- 2.7- Duties of Tournament Director
- 2.7.1- Shall be responsible for running the tournament during the annual SWSAD softball tournament.
- 2.7.2- Shall make an arrangement to select competent scorekeepers for all games.
- 2.7.3- Shall make arrangements to inspect the official softball field, hotel and facilities. PASSED

#### Proposal #3—New Proposal

Old Article—4.1.2 The club renewals shall be fifty dollars (\$50.00) per year with the deadline of <u>January 1<sup>st</sup></u>. Failure to remit renewal dues shall result in a twenty dollars (\$20.00) fine payable to SWSAD,.

New Article 4.1.2 The club renewals shall be fifty dollars (\$50.00) per year with the deadline of <u>April 1<sup>st</sup></u>. Failure to remit renewal dues shall result in a twenty dollars (\$20.00) fine payable to SWSAD.

Proposal #4—New Proposal

Old Article—4.2.1 Transportation expenses for the SWSAD Executive Committee to the Tournament City, equivalent to a round trip supersaver fare minimum one hundred dollars (\$100.00) and/or plus ground transportation (between headquarters hotel and airport) shall be paid out the host club on a one hundred percent (100%) basis, plus allowance of twenty dollars (\$20.00) per day for meals shall be paid out of SWSAD treasury.

New Article—4.2.1 Transportation expenses for the SWSAD Executive Committee to the Tournament City, equivalent to a round trip supersaver fare minimum one hundred dollars (\$100.00) and/or plus ground transportation (between headquarters hotel and airport) shall be paid out the host club on a one hundred percent (100%) basis, plus allowance of <a href="twenty-five dollars (\$25.00">twenty-five dollars (\$25.00</a>) per day for meals shall be paid out of SWSAD treasury.

Proposal #5—New Proposal

Old Article 4.3.1 The host club shall remit to the SWSAD a registration fee of ten dollars (\$10.00) plus NSAD registration fee/surcharge, if any for each person attending any event. The SWSAD Secretary/Treasurer shall be provided with registration forms at the end of the tournament. Willful failure on the part of the host to comply with this section shall result in action by the SWSAD Executive Committee.

New Article 4.3.1 The host club shall remit to the SWSAD a registration fee of <u>fifteen dollars (\$15.00)</u> plus NSAD registration fee/surcharge, if any for each <u>spectator excluding players</u> attending any event. The SWSAD Secretary/Treasurer shall be provided with registration forms at the end of the tournament. Willful failure on the part of the host to comply with this section shall result in action by the SWSAD Executive Committee.

Proposal #6—New Proposal

Old Article 4.9 The SWSAD financial fiscal policy shall be held once a year from January 1<sup>st</sup> to December 31<sup>st</sup>. The budget proposal shall be referred to Budget Committee for an approval. The budget policy shall be reported at the annual SWSAD softball tournament.

New Article 5.1.9(a) All SWSAD member club may report to SWSAD Secretary/Treasurer to add or delete names of player(s) on the suspension list within sixty (60) days after each regional softball tournament between time to time periods.

- 5.1.9(b) Any SWSAD member club who report to SWSAD Secretary/Treasurer to add or delete names of player(s) on the suspension list must provide the documents/evidence/written requests that the player being suspended owes one hundred dollars or more (\$100:00+); in turn when the SWSAD Secretary/Treasurer finds all in order and shall send them off to the NSAD Executive Board for their final decision.
- 5.1.9© Once suspended, the player(s) may be reinstated upon the payment of the debt in full to the former club, and or team provided that the copy of the receipt(s) are furnished to the SWSAD Secretary/Treasurer.

# Proposal #12—New Proposal

Old Article 3.2 Only authorized managers are allowed to bid on behalf of interested blubs to host next tournament <u>two (2) years</u> hence. To make valid bids, they must be presented to the managers' meeting.

New Article 3.2 Only authorized managers are allowed to bid on behalf of interested blubs to host next tournament three (3) years hence.

#### Proposal #13—New Proposal

Old Article 3.2.4 The bidding shall be done alternately on an East-West basis. The East comprises the clubs located in Arkansas, Louisiana, Mississippi, and environs of Memphis, Tennessee. The West comprises the clubs located in Oklahoma and Texas. The eligible group is the one (1) in which SWSAD softball tournament is scheduled for other group. For example: SWSAD softball tournament is to be held in the West group and the East group is eligible to bid for softball tournament that year. The bidding may be done two (2) years in advance.

Old Article 3.2.4 The bidding shall be done alternately on an East-West basis. The East comprises the clubs located in Arkansas, Louisiana, Mississippi, and environs of Memphis, Tennessee. The West comprises the clubs located in Oklahoma and Texas. The eligible group is the one (1) in which SWSAD softball tournament is scheduled for other group. For example: SWSAD softball tournament is to be held in the West group and the East group is eligible to bid for softball tournament that year. The bidding may be done three (3) years in advance.

#### Proposal #14—New Proposal

Old Article 3.5 The <u>SWSAD Deputy Commissioner</u> shall investigate the site of the official softball fields' complex, the hotel, and the facilities selected by the tournament host well in advance of the tournament and <u>report same to the SWSAD Executive Committee for its decision/approval.</u> Shall be reimbursed for transportation and lodging, if any, by the tournament host.

New Article 3.5 The <u>Tournament Director</u> shall investigate the site of the official softball fields' complex, the hotel, and the facilities selected by the tournament host well in advance of the tournament. Shall be reimbursed for transportation and lodging, if any by the tournament host.

- 2.2 Based on the statistics, ten (10) first (1<sup>st</sup>) team players who have the highest batting average with 12 or more at bat; shall go the first (1<sup>st</sup>) to third (3<sup>rd</sup>) team places.
- 2.3 Based on the statistics, ten (10) second (2<sup>nd</sup>) team players who have the highest batting average with 12 or more/less at bat in the descending order; shall go to all the teams.
- 2.4 The Most Valuable Player (MVP) shall not receive any All Tournament player award.
