### **Deputy Commissioner Report: Chris Reagle**

- I started my duties as SWSAD Deputy Commissioner last October 1<sup>st</sup>, 2009; there was not much to do. Finally I started my part with the Gerald Fleming Jr case last February. Gerald was told that he had been suspended from SWSAD. So I attempted to contact Jimmy Mitchell who was coach for Tulsa Team at that time. But no responses from Jimmy, I decided to move on. So there was never a case since no one reports to us the SWSAD Board. Then again in May, Gerald insisted some answers from us about his suspension. I told him that it was never brought to our attention about it. I told him that he could play any teams in the SWSAD Region.
